# **1. EXECUTIVE SUMMARY**

# **1.1 INTRODUCTION**

The college is affiliated to Mahatma Gandhi Kashi Vidyapeeth, Varanasi (UP) and attracts students for higher education in friendly environment because of availability of a large number of subject choices, familiar and affectionate relation between students and teachers, research supervision by experienced faculty and the tradition of quality education.

Presently, there are four faculties Arts, Science (Strengthened under DBT Star College Scheme), Commerce and Education with the student, teaching staff and administrative/technical/supporting staff strength of 6451, 109 and 36, respectively. Over all 22 departments offer undergraduate programmes in their respective fields, out of which 19 departments run postgraduate and Ph.D. programmes. In the last five years the college has introduced one new programmes i.e Physical Education in Undergraduate programme in the year 2019. Besides, college has 03 boys plus 01 girls unit of NSS, one unit each of Rovers –Rangers and one company of NCC cadets.

The college has adequate facility for indoor and outdoor games. The college also publishes its own annual magazine "*Manisha*" to instill the innovative behaviour in faculty, staff and students.

The affiliating University Mahatma Gandhi Kashi Vidyapeeth is responsible for designing the curricula and the senior faculty members of the college are involved in such process in capacities of members and conveners of the Board of Studies of University.

The college also has been recognized as a Study Centre of IGNOU, New Delhi, Rajarshi Tondon open university and Company Secretary course.

The College has well established Institute Innovation Council with **3.5 star rating** and recieved recognition in **Performer band** in **ARIIA**.

Located in a rural area and catering to the needs of the students belonging to different sections of the society for more than fifty years, the college has earned an esteemed reputation and is making notable contribution in the development of society and initiated new courses and options to the students suitable for the needs of emerging trends of employment in national as well as global markets.

## Vision

The Kashi Naresh Government Post Graduate College, Gyanpur was established in 1951 by the State Government of Uttar Pradesh as one of the pioneering institutes of higher learning with the vision of providing access to the students of rural and under developed areas to higher education with the aim of providing high quality education at their doorsteps, at minimal economic cost through optimal utilization of available resources. - The college has remained sensitive towards its social responsibilities in combatting the Covid pandemic and is an active center for vaccination drives in the nearby adjoining area.

## Institutional Weakness

1. Being a government college, the institute faces a number of financial, administrative and academic bindings. As an affiliated college, KNPG College, Gyanpur has no autonomy in academic reforms

2. Constraints in procuring financial resources in upscaling the infrastructure standards for upgradation of infrastructure and developmental projects is often a challenge, which results in either stalling or shelving development works in the college.

3. Lack of qualified technical and support staff especially in the college library.

4. Owing to the peripheral location of the college, very few reputed organizations participate in the process of student placement.

#### **Institutional Opportunity**

The college has substantial potentiality for enhancing/expanding its educational operations by bringing about innovative changes in teaching-learning-evaluation, library and laboratory resources with the support of its qualified teachers. Location of the college is partially rural that attracts students from the adjoining far-flung outskirts; these students have immense untapped talent that can be transformed into resource. The college has recently inaugurated spaciously verdant Herbal Garden where students are actively engaging themselves. Enhancement in the number of faculties is enriching the potential of the college in imparting quality education considerably where several teachers are also engaged in blended learning modules. The college has opportunities for establishing additional linkages with other institutions/organizations of the state to enhance the quality of its outreach programmes.

#### Institutional Challenge

- Being an affiliated government College, infrastructure is a major challenge especially for the departments under the Arts stream departmental spaces for teachers, and for departments under the Science stream more laboratory spaces are needed for progressive development.
- The College caters to a large number of students who hail from the marginalized sections of society. The challenge of meeting their day-to-day educational needs and nurture them to aspire for higher ambitions is an urgent need. Furthermore, female students with promising potential are often

discouraged by their families from active participation in academic and co-curricular events.

• The initiation of any new academic programme requires a long and complicated procedure for getting permissions from multiple authorities which often delays the process.

# **1.3 CRITERIA WISE SUMMARY**

## **Curricular Aspects**

- K. N. Govt. PG College, Gyanpur, Bhadohi is an affiliated college of Mahatma Gandhi Kashi Vidyapeeth, Varanasi and as such follows a predetermined syllabus. However, the college faculty members participate as members of Board of Studies of University and make suggestions in reforming the syllabus time to time.
- CBCS system in our college is started with the implementation of NEP2020 in the year 2021-22. With the start of NEP-2020, the faculty members has designed 18 minor elective and 07 skill development courses that was approved by the affiliating university. Before this system elective course was available in postgraduate curricula of final year students.
- With the commencement of session every department prepare the academic plan and adhere with it.
- To imbibe the human values, there is a compulsory paper for first year students in the form of Rashtra Gaurav and to aware our students with the Environmental sustainability there is a dedicated paper for undergraduate IInd year students.
- Complementing these pursuits is the strong tutorial and mentor-ward system. Groups of students are created, so that academic and other discussions are individualized.
- Feedback is taken on forms available on website, the data is compiled, analysed and shared with each Department and concerned individuals for prompt action. Channels for communication with different stakeholders are kept warm by responding to diverse needs. The IQAC conducts annual internal audits and all Departments are encouraged to undertake self-assessment to critically reflect on their practices.

## **Teaching-learning and Evaluation**

- K. N. Govt. PG College Gyanpur admits approximatly 5500 students annually, including admissions as per the reservation policy of the Government of India.
- Teachers assess the academic proficiency of students based on their performance in classroom discussions and tests/assignments. Needs of slow learners are particularly attended to in tutorial sessions.
- The college also has an effective mentor-mentee system for practical subjects and also for counselling. Students are also mandated to participate in co-curricular activities like field trips and industrial visits. These activities heighten experiential learning. National conferences and Exhibitions organized in the college also provide opportunities for students' developments in academics. The 4 Science Departments Botany, Chemistry, Physics and Zoology were strengthened under DBT Star College Scheme. To inculcate research interests among students, they are encouraged to be part of minor research projects supervised by faculty members under this scheme.
- To maintain a healthy student-teacher ratio (2021-22 ratio is 60 : 1), well-qualified full-time teachers are appointed against sanctioned posts in accordance with UGC guidelines.
- Blended teaching-learning methods that employ both ICT and traditional classroom practices make learning more effective. The COVID-19 pandemic threw up new vistas of online teaching-learning, thus ensuring continuity as well as change in learning experiences.

## **Research, Innovations and Extension**

- The college promotes research as an integral part of its academic environment to enhance research culture in the institution. Most of the Departments have faculty members recognized as research guide and the college is also a recognized center of Ph.D. Course Work. Beside these 6 teachers of the institution are running minor research projects funded by the U.P. Govt. Faculties are actively involved in publishing papers of National and International Repute which also follow UGC Norms. The Research and Development sub-committee promotes research initiatives in the institution. It functions under IQAC.
- With the establishment of Institute Innovation Council (IIC) under the guidance of Innovation cell of Ministry of Education in the year 2018, the college has created an ecosystem for innovation. Under the aegis of IIC, several sessions were organized related with the IPR and Entrepreneurship. Every year, our students with their innovative ideas participate in National Innovation Contest of Proof of Concept. To promote the culture of I&E, the faculty members who have completed their Innovation Ambassador Training organizes sessions for other colleges too.
- The college promotes several extension activities through NSS Units and some other committees, constituted for the purpose of sensitizing students about social needs. Students take up activities like cleaning the college campus and its surrounding and plantation of tree saplings as a part of effort to preserve a clean and healthy environment. Students have also participated in drives like 'Swachh Bharat' and 'Swachhta Pakhwada' programmes. NSS volunteers and NCC cadets have regularly participated in programmes organized towards observing days of social importance such as World AIDS Day, World Environment Day, World Yoga Day.
- The college received Green Champion Award By MGNCRE, 3.5 star rating for IIC and Performer band in Atal Ranking of Institutes on Innovation Achievements.
- The College has signed 9 MoUs for the academic growth of Students with other institutions. These include MoUs with DBT New Delhi, Company Secretary study center, Rajarshi Tondon Open University, IGNOU, Abhyuday Coching Yojna Bhadohi, Incubation Center BHU, DELNET and Govt. ITI, Gyanpur Bhadohi

## **Governance, Leadership and Management**

- The college is run by U.P. state government and has well defined vision and mission and dedicated efforts are made for quality and value based education. All the employees are bound to follow Govt. of UP department of higher education rules.

- Under the DBT Star scheme in the science departments, the students are engaged in hands-on training, workshops, minor research project and other activities.
- Guest lectures are organized both in offline and online mode for students under the DBT scheme.
- College organized several workshops under Institution's Innovation Council to orient students towards innovation and Entrepreneurship.
- Departmental specific activities like one-day field trips, study tours, industrial and institutional visits are organized by Botany, Zoology, and Geography department and these are the parts of their curriculum.
- Student's presentations are part of the learning process. Students are divided into small groups and are encouraged to teach other students in particular subjects under Cooperative learning. In Science Departments, seminars are organized for Post Graduate students where they present their alloted work in the form of PPTs.
- Students actively participate in co-curricular and outreach activities organized by various committees of the college.
- Students are encouraged to contribute to the college magazine 'Manisha'.
- All faculty members of K.N. Govt. P.G. College uses the latest ICT tools to make the teaching-

learning process interesting. There are eleven projectors in the college and the whole campus is wifi enabled. Printers and Scanners are also available in departments. In offline mode teachers uses these tools in their teaching.

• Due to the COVID-19 pandemic, regular online classes were taken by the faculty members using the Microsoft Teams App, zoom, Google meets, Google class, WhatsApp group, and also provided the learning materials and video lectures. **2.5.1** Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

## **Response:**

K.N. Govt. P.G. College is an affiliated college of the University, Mahatma Gandhi Kashi Vidyapith and is guided by the regulations formulated at the University level in all matters of syllabi, examination, and evaluation progress. In the current session credit based evaluation system has been started. Each Department ensure that teachers take regular class tests, assignments, presentations, etc. as a part of the initiative taken by the college for effective evaluation of the students.

- The progress of students is monitored through regular assignments, presentation and Mid term Examination. The breakup of Internal Assessment as prescribed by the University is as follows: 10 % through Class Tests and Tutorials; 10% through Assignments, Projects and Presentations; 5% through Attendance.
- Assignments and tests are regularly conducted and students are given multiple opportunities to improve their performance.

The final evaluation of students is the sole responsibility of the University. Our Faculty members made their contribution in External Examination as paper setter, Evaluation of the answer sheets and as External and Internal Examiners of practicals and viva. The institution addresses all the cases of grievances regarding evaluation to the University for redressal.

## **Internal Examination:**

The students are provided with the corrected answer-scripts by the relevant faculty members. The doubt and enquiries of the students regarding the pattern of optimal answers are clarified by the examiners. If there is any tabulation related error in the assessment, corrections are duly made by the examiner and the corrected marks is officially posted against the name of the concerned student. If there is a marked discrepancy between class-performance and performance in examination of a student, the teachers consider it to be their responsibility to identify the cause behind such discrepancy. The interaction between the parents and the relevant faculty members can be crucial for such identification. If the reason for such discrepancy is purely academic, the teachers try whole-heartedly to provide the students with a broader understanding of the subject of their study (topics already taught in the class are discussed again, students are given time-bound home assignments to be checked by the faculty members, more books and journals are suggested to the students for reading and so on). However the cause may be extra- academic too. In case the student suffers from psychological instability or examination-phobia, the faculty members try to deal with the suffering students and their parents sympathetically.

As per University guidelines for the courses offered in UG, 25% marks in each course are awarded through internal assessment and 75% marks externally through end-semester examination. The University further stipulates that internal assessment be based on attendance (5%), class test (10%) and assignments or presentations (10%).

Following these guidelines, the faculty evaluates students on a continuous basis, providing opportunities to students to improve their performance.

Individual as well as group assignments are given to students for direct measurement of programme and course outcomes. Students are encouraged to give presentations on specific topics.

Many curricula involve the conduct of practical experiments in laboratories. Viva-voce is a part of the process of evaluation in these courses.

Results declared by the University at the end of each semester are thoroughly analysed in internal academic audits of departments. List of merit holders of college in university are also published in the annual report of the college and college website too. Department faculty meets students whose performance is below par and assesses reasons for poor performance.

In the year 2017-18, the U.P Govt. has taken initiative for academic audit but later this was not done. From 2020-21, the college has taken initiatives for internal academic audit however the process is yet to fully

implement in all Departments.

The college facilitates the professional growth and enrichment of the staff by implementing an effective Performance Appraisal System. This system is maintained with the objective of improving academic and administrative standards. It functions in the following ways.

Teacher Performance Record (TPR):It is given to each teacher at the beginning of every academic year to record their everyday engagements. All details pertaining to lesson plans, tests, assignments, projects, and mentoring, tutoring, remedial classes, leave taken etc. are recorded. It is monitored by the head of the department and the principal. Faculty members are also evaluated on the basis of various responsibilities entrusted on them as extracurricular and extension activities.

Peer Evaluation:IQAC designs peer evaluation to provide feedback to peers about their academic performance. Peer Evaluation helps faculty members to improve their teaching. It is a collaborative process in which the faculty works closely with a colleague or group of colleagues to discuss his or her teaching. It provides the teacher with insights into his/her academic contribution.

Faculty evaluation by the students IQAC monitors the feedback mechanism in the college. In each semester the students can evaluate their teachers online on the basis of their performance. The students can

assess the teachers on the following criteria: accessibility to teacher, classroom management, communication skills, fairness in internal assessment, ability to inspire and motivation, interaction of the teacher, punctuality and regularity, effective completion of syllabus in time, subject knowledge and the use of ICT in teaching learning process. Paper, Cloth Bag Making workshops and Anti-Plastic awareness rallies are conducted. Students are encouraged to share their notes and collect one-sided used or printed papers and reuse them. Drug awareness, Peace, Non-Violence awareness campaign and anti-tobacco pledge were conducted.

IV. COVID TIMES: Students and teachers were encouraged to undertake Janta Curfew pledge during lockdown to show their responsibility as citizens. NSS and Rovers/Rangers gave messages to students and citizens to stay at home and prevent spread of virus. The Institution is taking maximum efforts to ensure safe environment in the College. Staff are asked to come to College in a distributed manner Security personnel check the temperature, pulse and oxygen of any person who enters the campus. The staff room, laboratories and office are frequently sanitized. It is compulsory for any person entering the College to wear a mask and maintain social distance. All activities are continued through online platforms.

**Best Practice-1** 

Title: Development of E-content and use of online platforms for teaching learning

Objective: To provide knowledge and understanding of the subject to students of not only our but the

students of other colleges too.

**Context**: During Covid-19 it was needed to reach our students online. So the efforts were made to develop E-Content in form of Video lecture and text. These e-contents made available on Digital Library of Higher Education U.P. So that students of not only our college but also the students of other colleges can also get benefitted. Once the students get exposure to online platform we decided to enhance the use of online platform so that teaching would not suffer by pandemic condition. Our Government colleges are situated generally in rural areas and students belong to economically poor section. So they do not afford higher internet bandwidth for online classes. But to combat the COVID situation, it is necessary to use online platforms.We have taken Microsoft Teams subscription and teachers started blending mode of teaching. Recording of these classes made available on their whatsapp group so those who are not able to join online class can able to see recordings.

**The Practice:** Each and every Faculty member prepare e content and uploaded it on the digital library created by U.P. Higher Education. These e-content can be easily searched by the students and downloaded.

The College has taken Microsoft Teams subscription and teachers shifted towards blending mode of teaching and learning process. Besides Microsoft Teams faculty members uses other online teaching learning platform like ZOOM and Google meet. Recording of these classes made available on their whatsapp group so those who are not able to join online class can able to see recordings. IQAC ensure that every faculty member to complete their course on time during prevailing pandemic situation create a google form link where teacher send details of online classes taken by them.

Time to time teachers took internal assessment through google form and socartive so that they remain updated with student progress in respective subjects.

**Evidence of Success**: 469 E-contents developed by the faculty members and uploaded on Digital Library. Now every student of Uttar Pradesh can search content either by concerned subject or by concerned faculty name. The College is recognized as the 3rd top college who has uploaded maximum e-content in digital library of Higher Education, U.P.

#### **Best Practice-2**

Title: Imbibing the culture of Innovation and Entrepreneurship through Institute Innovation Council

**Objective**: To create an awareness of Innovation and Entrepreneurship culture.

**Context**: K.N. Govt. PG College is one of the biggest Government college of U.P. where every year about 6000 students take admission. 90 percent of them belong to rural area and have hub of innovative ideas. As these students experiences lack of resources, to overcome these situations they have alternative innovative ideas. To channelize their idea, college has established Institute Innovation Council in 2018 under the guidance of Innovation cell of Ministry of Education, India.

**The Practice:** With the beginning of this council, a no. of awareness programme related with the innovation and entrepreneurship were organized. Students and faculty members were motivated to be part of these programmes. With every passing year, this council become more strengthened.

During Pandemic situation innovation cell of Ministry of education 17 online e-sessions. During these sessions, they learn how to think critically, how to identify right problem with its right solution, business model canvas and how to file IPR.

Every year IIC organizes a field visit for students in nearby areas so that they can identify local problems as well as get their innovative solutions.

#### **Evidence of Success**:

No. of innovative ideas submitted to our IIC is increased every year. In the year 2018-19, our two students namely Md. Mushfique Khan and Vikash Pandey participated in National Level proof of concept competition that was organized at New Delhi. After that 3 more ideas were selected for further prototype level. These ideas were Face Sanitizer submitted by Mohd. Mushfique Khan, M.Sc. III rd Semester, Botany, Earhealer and Farmer's Music by Mr. Ritesh Srivastava, M.Sc. III rd Semester, Botany, Their prototype were submitted by IIC in National Innovation Contest 2020. It's a matter of pride for our IIC that out of 3, two prototype Face sanitizer and Earhealer were selected by innovation cell for further level mentoring.
